

Mr. Moore,

I am requesting that we purchase one 2026 Thomas Built Bus Saf-T-Liner C2 Special Needs (60 passenger before conversion) and two 2026 Thomas Built Saf-T-Liner C2 72 Passenger buses. These buses will replace our 2011 special needs bus and two 2015 72 passenger buses.

The cost of the buses are as follows:

Special Needs Bus: \$141,988

Regular 72 Passenger Bus: \$139,948 (\$279,896 for both)

Total for all 3 buses: \$421,884.
